The risk of injury from the activities involved in any sport is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my safety while using equipment created, modified, or repaired by Hex Carbon Workshop; and,

I willingly agree to comply with the care and maintenance guide provided to me by the original manufacturer at the time of purchase. If I did not receive one, I will consult with an authorized dealer or manufacturer for proper care and maintenance instructions. If, however, I observe any signs of damage including visible signs of change such as movement, flexing, separation, cracking, chipping, flaking, or discoloration, OR audible signs such as creaking, cracking, or crunching noises, OR physical signs such as changes in the firmness of the carbon fibers, I will immediately discontinue use of the product and bring such information to the attention of Hex Carbon Workshop or an authorized service point; and,

I understand that Hex Carbon Workshop does not own nor have access to any testing device(s) that would allow an absolute guarantee of structural soundness of any structure, component, or part, before or after modification, and I am the sole party responsible for deciding if any structure, component, or part is sound and safe to use for the intended purpose each time it is used; and,

4) I, for myself and on behalf of my heirs, assignees, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS Hex Carbon Workshop, and, if any exists, the Authorized Service Center utilized for the repair or modification and their officers, officials, agents, and/or employees, sponsors, business partners, advertisers ("RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law. I hereby further agree that this Waiver of Liability and Hold Harmless agreement shall be construed in accordance with the laws of the State of Arkansas.
